1. Nirankari Rajmata Scholarship Scheme Sponsored By Sant Nirankari Charitable Foundation :

Eligibility Criteria :- (a) The candidate must have scored at least 90% marks in class 12. (b) He/ She should have taken admission in a professional degree programme as a regular student in a government recognized institution through a competitive exam. (c) Family Income must not exceed Rs. Three Lakh Fifty Thousand only (Rs.3. 50 lakh) per annum from all sources.

Award and Application Process :- Selected students will be eligible to receive Rupees Fifty Thousand (Rs. 50000/- only) per annum or tuition fee whichever is less for that particular year. Students are required to secure 75% marks every year for renewal of their scholarship in the following years of their course. Please apply before **end of September** as the scholarship shall be awarded by end of December by the foundation.

Application period :- Applications period is August to September.



- Family income from all sources must not exceed Rs. Six lakh per annum.



**NATIONAL SCHOLARSHIP PROVIDED BY MINISTRY OF HUMAN
RESOURCE DEVELOPMENT, GOVT. OF INDIA.**
(ACADEMIC SESSION 2019-2020)

Kind attention of students is invited to the following scholarship scheme provided by Ministry of Human Resource Development, Govt. of India. This is provided to meritorious brilliant students who come from economically weaker sections of the society.

Central Sector Scheme of Scholarship for College and University Students -

Eligibility Criteria :- (a) The applicant must be a regular student studying courses related to Science, Commerce, Humanities stream. (b) The scholarship is open to all categories of students who are above 80th percentile of successful candidates in the relevant stream from a particular board of examination in class 12. (c) Family income should be less than Rs. Six Lakh (Rs. 6.00 lakh) per annum from all sources. (d) The candidate shall not be receiving any other scholarship.

Award of Scholarship :- The selected students shall be provided a scholarship of Rs. 10,000/- per annum at graduation level for the first three years of College and University courses and Rupees Twenty Thousand (Rs. 20,000/-) per annum at the post graduation level. Students pursuing professional courses shall be paid Rupees Twenty Thousand (Rs. 20,000/-) per annum in the 4th and 5th year.

The scholarship shall be renewed annually on the basis of performance, attendance, and maintenance of discipline during the previous year. Interested students can apply online on the National scholarship portal before end of October. Students are advised to read the Guidelines/FAQ's and other details about the scholarship scheme available on the official website prior to application. **MERIT CUM MEANS SCHOLARSHIP FOR PROFESSIONAL AND
TECHNICAL COURSES - CENTRAL SECTOR (MINORITIES).**
(ACADEMIC SESSION 2019-2020)

Kind attention of students belonging to minority categories is invited to the Merit Cum Means Scholarship for professional and technical courses – central sector (minorities) provided by Ministry of Minority Affairs, Govt. of India. Under this scholarship scheme, economically weaker but meritorious students belonging to minority communities get monetary support to pursue their higher studies.

Eligibility Criteria :- (a) The candidates must have taken admission through competitive examination in a recognized College or University to pursue professional/ technical courses. (b) He/ she should have a minimum of 50% marks at higher secondary/ graduation level (final examination of the previous year). (c) Selection of students for award of scholarship shall be done strictly on merit basis. (d) The applicants should belong to the low income family and the application should be submitted to the state or Union Territory to which he/she belongs.
